4. What kinds of products are sold containing arabinose e.g. in foods and supplements?
5. What volumes are sold, and what total volume has been consumed since its introduction?
6. Have any adverse effects been reported? For example, has there been any adverse press?
7. What additional work has been undertaken in Japan on arabinose?

Additionally, the study sought to find information on the companies which are selling arabinose in Japan and the marketing reception.
