4. How does this product compare to other soluble fibres?
5. Is it worth investing a significant amount of effort working on the regulations and science in order to get this product to market?

METHODS

This study assessed and analysed the issues in sufficient depth to allow strategic conclusions to be drawn.

The main contents of the study were based on the information provided by the client to CPL as well as sources, including in-house data, CPL's network of contacts (the CPL Value-Net) and publicly available information (e.g. data from government agencies, patents, scientific journals, trade press and internet etc.).
